

## Larimer County Behavioral Health Services at Longview Campus & Acute Care



### Key Points:

- Longview refers to the Larimer County Behavioral Health Services Campus
- Acute Care refers to the first building on the campus opening in Fall 2023.
- Larimer County-funded project with services provided by SummitStone Health Partners in partnership with UHealth.

### Larimer County Behavioral Health Services at Longview Campus

This important project is funded by a successful 2018 ballot initiative that directs a .25% countywide sales-and-use tax on behavioral health needs in Larimer County.

Situated on the northwest corner of Taft Hill Road and Trilby Road, the 40-acre campus will house various behavioral health services and supportive care.

The first building located on the campus, Acute Care, will help address a critical gap in behavioral health crisis services within the County.

The next building planned at the campus is Adolescent Care, another critical need in our community. The county has applied for American Rescue Plan Act (ARPA) funding to help support the accelerated completion of the project. Adolescent Care is anticipated to open in 2025.

The name **Longview** was inspired by the local landscape and proximity to Long View Open Space and Long View trails found in this part of the county.

By definition, "long view" refers to an approach to a problem or situation that emphasizes long-range factors. The name serves as a metaphor for the journey of mental health and recovery.

### Acute Care

The construction of the Acute Care facility is funded by a 20-year Larimer County ballot initiative that directs a portion of a countywide sales-and-use tax to behavioral health programs that serve the community.

Acute Care, the first building situated on the Larimer County Behavioral Health Services at Longview Campus, will provide care to individuals in behavioral health crisis. Services within the facility will be provided by SummitStone Health Partners in partnership with UHealth.

Acute Care, a partnership between Larimer County and SummitStone Health Partners, is the first building constructed on the Longview Campus.

Acute Care is expected to open to the community in December 2023 with 24/7 behavioral health urgent care, crisis services, and withdrawal management care.

### **Acute Care Services**

SummitStone Health Partners will provide a phased approach to the opening of the Acute Care facility. Upon opening, they will offer the following services available to the community:

- Behavioral Health Urgent Care: Available 24/7
- Care Coordination
- Substance Use Treatment with Medications
- Withdrawal Management
- Crisis Stabilization Unit (CSU)
- Onsite pharmacy and lab

Future Phases of Acute Care will be based on community need.

- Short-term intensive residential treatment (IRT) - Short-term residential program for clients focused on recovery.
- Opioid Treatment Program (OTP)
- Behavioral Health Institute / Center of Excellence for Training and Professional Development
- Expansion of existing services

### **Construction**

As of February 2023, construction on the Acute Care facility is almost 71% complete.

The Acute Care building was designed by the architecture firm, Page Southerland Page.

Haselden Construction is the general contractor overseeing the construction of Acute Care and Ditesco serves as the owner's representative for the project.

### **Future Initiatives**

The next building planned on the Longview Campus will be dedicated to adolescent care and is anticipated to open in 2025. The vision for the Longview Campus is to provide the community with affordable and accessible behavioral health care and related services.
